### MORE REGULATIONS TO ENCOURAGE AIRLINE HONESTY

Those cheap airline fares that you see advertised in the newspaper will begin to look more expensive by mid-February. The Transportation Department is forcing airlines to be more upfront about what your flight will really cost. As part of a new set of consumer-protection rules, they will be requiring airlines make sure that their advertised fares include all government taxes and other fees that now are often hidden behind asterisks or stuck in footnotes, but which can add 30% to 50% to a ticket price. Airlines must also include any fees for checking bags when you book and pay for a ticket online.

#### KICKING HORSE PURCHASED

Resorts of the Canadian Rockies (RCR) has purchased Kicking Horse Mountain Resort from Ballast Nedam who started the resort 11 years ago. Resorts of the Canadian Rockies is one of the largest resort owners in North America and now owns six ski resorts in Canada, including Nakiska Ski Area in Alberta, and Fernie Alpine Resort and Kimberley Alpine Resort in British Columbia. Kicking Horse Mountain Resort is located two-and-a-half hours west of Calgary, between the Purcell and Rocky Mountains in British Columbia, and sees an average of 23 feet of powder a year, with 27 trails and 106 runs on 2,750 acres.

#### VAIL'S NEW GONDOLA TO CELEBRATE 50TH ANNIVERSARY

Vail Mountain is constructing a new gondola to replace the 26-year-old Vista Bahn Express lift in Vail Village. Completion of the new gondola will coincide with Vail's 50th anniversary in December 2012 -- just in time for the opening of the 2012-2013 ski season. The state-of-the-art gondola will even offer free Wi-Fi on board. It is, of course, subject to Town of Vail and U.S. Forest Service approval.

#### TRIP CANCELLATION POLICY

- A cancellation date for each trip will be published in the club newsletter. If one is not published, the cancellation date will be 60 days before departure.
- You must tell the trip chair in person and in writing postmarked before the cancellation date to be eligible for a refund.
- 3. If we cancel the trip, you get all your money back.
- If you cancel your reservation before the cancellation date, you get all your money back. Talk to the trip chair about your refund.
- 5. If you cancel your reservation after the cancellation date, you will lose some money. If we cannot fill the reservation, you will lose either your initial deposit or any non-recoverable loss to the club, whichever is greater. If we fill the reservation, you will owe either \$25 or the amount that we have to pay to change the reservations whichever is greater.
- Empty spots will be filled first from the waiting list. If there is no waiting list, it is your responsibility to find a replacement in order to cut your losses.
- You can appeal any cancellation fees to the Board of Directors, if you feel that you have good reasons for the cancellation.
- Refunds may be held until the trip has been completed, and it has been determined what losses were incurred because of your cancellation.
